I further understand that I am to continue all medications and other treatment modalities as they may have been prescribed until otherwise directed by the practitioner who prescribed them. I agree that Eternal Self Ministries is an ecclesiastical jurisdiction and is the exclusive body with authority to decide or rule in any matter of dispute or disagreement between the Parties hereto. In the event, I am dissatisfied with services provided by Member or otherwise, I am entitled to file a formal complaint through the Disciplinary Council division of Eternal Self Ministries at

Upon receipt of complaint Eternal Self Ministries will initiate an investigation in accordance with the Code of Ethical Standards. In the event Eternal Self Ministries determines evidence exists to initiate a formal inquiry, Eternal Self Ministries will appoint an arbitral tribunal as the agreed sole remedy to evaluate and rule on such complaint. I understand that all procedures, Native Indigenous Ceremony and Medicine, Sacrament, meditations, affirmations, energy exchanges, prayers, Yoga practices, therapies, sessions, protocols, Laying on of Hands (Chirothesia), and or other natural, non-invasive, holistic practices, ceremonies and healing conversations are private practices conducted by authorized members of Ecclesiastical/ Church Domain and Eternal Self Ministries., a 508c1a Faith Based Organization (FBO): The 508(c)(1)

(a) Faith Based Organization (FBO) is a religious, non-profit, tax exempt organization. The 508(c)(1)(a) FBO is separate and distinct from a 501(c)(3) charity and unincorporated FBO's. An unincorporated FBO by definition is a First Amendment Church/Organization. The 508(c)(1)(a) is recognized by the Federal Government, by all 50 states and recognized internationally under the Hague Convention of the United Nations Charter. of which I am a member of Eternal Self Ministries, and that I am not receiving these above referenced services as a member of the public. As a member of Eternal Self Ministries I understand and agree that every time I book a weekend retreat I will donate 10% of the total for tithing.

I acknowledge that I have been told of the possible risks of all Eternal Self Ministries modalities, and I have been given satisfactory answers to my questions concerning any and all procedures and related matters without prejudice. Therefore, I indemnify and hold harmless Eternal Self Ministries and its agents against any and all liability in any way connected to my participation in the above activities.

I am an adult, aged 18 or older, legally and mentally competent to make informed decisions regarding my sincerely held religious beliefs, health, wellness and recreation. Additionally, I acknowledge that I am here on this day and every subsequent visit solely on my own behalf and not as an agent of any governmental agency. I swear that all information provided by me in support of receiving services from the above referenced practitioner are correct and true as a Pre-condition towards participating in any private Eternal Self Ministries counseling or wellness activities.

### **NINTH AMENDMENT DECLARATION: ARTICLE IX, U.S. CONSTITUTION**

“The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the People.” Under the Ninth Amendment to the Constitution of the United States of America, I retain the right to freedom of choice in health care (or psychological services, or educational services, etc...). This includes the right to choose my diet, and to obtain, purchase and use any therapy, regimen, modality, remedy or product recommended by the fellow member, therapist, doctor or any practitioner of my choice. The enumeration in this declaration of these rights shall not be construed to deny or disparage other rights retained by me, or my right to amend this declaration at any time.

Notice is hereby given to any person who receives a copy of this Declaration and who, acting under the color of law, intentionally interferes with the free exercise of the rights retained by me under the Ninth Amendment, as enumerated in this declaration, that they may be in violation of my civil and constitutional rights, Title 42, U.S.C. 1983 et seq. and Title 18, Section 241.
